



RES is the world's largest independent renewable energy company, operating internationally in the development, construction and asset management of utility-scale wind, solar, transmission, energy storage and hydrogen projects. The company works closely with large investment funds, including Macquarie and Blackrock, and comanages the assets of the GBP 3.2 billion UK listed fund, TRIG. RES's international footprint includes a significant presence in North America (the USA and Canada), Northern and Southern Europe and Australia.

#### 2017-2019 Chairman, WindEurope

Appointed by my industry peers as Chairman of WindEurope, an association based in Brussels which represents the interests of the European wind industry. Chaired board meetings, worked closely with the European Commission and hosted CEO retreats to ensure that the actions of WindEurope and its main membership were aligned.

#### 2008-2015 **Chief Executive Officer, Hyder Consulting PLC**

Hyder Consulting was an international engineering design consultancy with around 5,000 employees. The company was listed on the London FTSE until a hostile takeover by ARCADIS NV. The company operated in four market sectors - utilities, transport, property and environment - across five geographic areas - Australia, Asia, the Middle East, Germany and the UK. The client-facing countries were supported by design teams in India and the Philippines. Projects during my time included the world's tallest building, the Burj Khalifa in Dubai (828 metres high); the Hunter Valley expressway in Australia; a new submerged tube tunnel across Hong Kong Bay; and significant sections of Crossrail in London.

## 2003-2008 **Executive Board Director and Group Managing Director, WS Atkins** PLC

Initially managed the UK engineering consulting business streams of Energy, Water,





Defence & Aerospace. My remit was expanded in 2005 to also include Property and Environment, which included one of the UK's largest architectural practices. An overall design and engineering division employing around 5,000.
